

TRAINER FAQ, GUIDELINES and RESPONSIBILITIES

1. What to do BEFORE Shipping into Mountaineer

- MONITOR/LOG TEMPS on all horses for 1 week before shipping
- DO NOT GIVE ANTIBIOTICS/NSAIDs as a PREVENTION PLAN
- Do Not Move Horses until the farm you are on has been Tested. PERIOD.
- DO NOT Move SICK HORSES off Farm. Place them in a separate ISOLATION BARN
- Each Trainer is required to submit a list of ALL RACEHORSES in your care and indicate the Farm Location for each horse (This is to help with testing)

2. What will my horse need TO ENTER Stable Area

- a. 5 Day health Certificate
- b. 5 Day Negative PCR Test Result
- c. 12 Month Coggins (EIA) Certificate
- d. In-Bound Horse Declaration Form (Signed by Trainer)
- e. Go DIRECTLY to YOUR ASSIGNED STALLS and unload all horses
- f. Health Check will take place at your assigned Stalls after arrival
- g. Horses may not leave stall for training until HEALTH TEAM has checked all your horses.

3. A Stable Gate Schedule(Days/Times) to move horses will be provided

- The Goal is to limit movement of Horses until we know IF there is strangles in our incoming population.
- Resident Horses are to STAY at the Track once they arrive. They can't return to the farm until the Initial MNR 30 day Training Period is over and the situation is re-evaluated.

4. What to do AFTER my horses arrive at MNR

- a. Keep all your horses in ASSIGNED Stalls. Do cross-use stalls.
- b. Provide DAILY HEALTH CHECKS on all horses
 - Rectal TEMPS taken TWICE DAILY and LOGGED
 - Temps of 101.5 MUST be reported to WVRC Health Team
 - Daily OBSERVATION for clinical signs of sickness
 - Depression
 - Off Feed or Water
 - Nasal Discharge
 - Swollen Lymph Nodes
 - Fever
- c. **IMMEDIATELY REPORT ADVERSE Health Signs to WVRC Health Team**
- d. **SEE ITEM 5**

5. What to do if I have a horse get Sick

- a. **IMMEDIATELY REPORT ADVERSE Health SIGNS to WVRC Health Team**
 - i. See Item 4 for Signs of Sickness
- b. **IMMEDIATELY Isolate Sick horse in QUARANTINE BARN on PROPERTY**
 - i. Barn JJ-extension
- c. **IMMEDIATELY DISINFECT STALL of Sick Horse (Trainer) and DO NOT put another horse in that stall**
- d. Sick Horses are **NOT ALLOWED to LEAVE** without permission from WVRC Vet
 - i. No movement of ANY HORSE off Property without prior Permission
- e. In the **Event of an Emergency** and you need to remove a horse off property:
 - a. Contact the WVRC Stewards and/or WVRC State Vet
 - b. Once the horse leaves it will not be allowed back into Stable Area during Pre-Meet Training Period

6. Horses will be DENIED ENTRY for any of the following:

- a. No Inbound Declaration Form
- b. No 5 Day Health Certificate
- c. No 5 Day PCR Test Document
- d. No 12 month Coggins Certificate
- e. Clinical signs of sickness on ANY Horse in Trailer/Van
- f. Temperature of 101.5 or greater on ANY Horse in Trailer/Van

7. Follow BASIC BIOSECURITY GUIDELINES during 30 Day Training Period

- a. See Separate Handout
